

PRIVACY POLICY

This page describes how to manage the site in relation to the processing of personal data of users who consult it.

This is an information statement prepared on the basis of multiple legislative systems, including articles 13 and 14 of Regulation (EU) 2016/679 - GDPR - to those who interact with the web services of Villa Pirreca, accessible at the URL: VillaPirrecaFavignana.com corresponding to the homepage of the official site.

The information is provided only for the website VillaPirrecaFavignana.com and not for other websites that may be consulted by the user through links.

Definition

Personal Data (or Data)

Personal data consists of any information relating to a natural person, identified or identifiable, even indirectly, by reference to any other information, including a personal identification number.

Usage Data

This information is collected automatically from this website (or from third-party websites that this site uses), including: IP addresses or domain names of the computers employed by the user who connects to this website, the addresses in the notation URI (Uniform Resource Identifier), the time of the request, the method used in submitting the request to the server, the size of the file obtained in response, the numerical code indicating the status of the response from the server (good order, error, etc.) the country of origin, the characteristics of the browser and the operating system used by the visitor, the various temporal connotations of the visit (for example the time spent on each page) and the details of the itinerary followed within the web-site, with particular reference to the sequence of pages consulted, to the parameters related to the operating system and the IT environment of the User.

User

The individual that uses this website, which must coincide with the interested party or be authorized by him and whose personal data are being processed.

Interested party

The natural or legal person to whom the Personal Data refers.

Data Processor (or Processor)

The natural person, legal person, public administration and any other body, association or body appointed by the Data Controller to process Personal Data, as prepared by this privacy policy.

Data Controller (or Controller)

The natural person, legal entity, public administration and any other body, association or body that is responsible, even together with another owner, of taking decisions regarding the purposes, methods of processing personal data and the tools used, including the profile of the security, in relation to the functioning and use of this website. Any use of cookies - or other tracking tools - by this website or by third party service providers used by this website, unless otherwise specified, is used to identify the user and record the related preferences for purposes strictly related to the provision of the service requested by the User. Failure to provide some Personal Data by User may prevent this website from providing its services.

The User assumes the responsibility of the Personal Data of third parties published or shared

through this website and guarantees to have the right to communicate or disseminate them, freeing the owner from any liability to third parties.

Mode and place of processing of collected data

Mode of processing

The Data Controller processes the Personal Data of Users by adopting appropriate security measures to prevent unauthorized access, disclosure, modification or destruction of Personal Data.

Processing is carried out using IT and / or telematic tools, with organizational methods and with logic, strictly related to the purposes indicated. In addition to the Data Controller, in some cases, some categories of employees involved in organization of the site may have access to the Data (administrative, commercial, marketing, legal, system administrators) or external subjects (as suppliers of third party technical services, postal couriers, hosting providers, IT companies, communication agencies) also appointed, if necessary, Data Processors by the Data Controller. The updated list of Controllers can always be requested from the Data Controller.

Place

The Data are processed at the operational headquarters of the Data Controller and in any other place where the parties involved in the processing are located. For more information, contact the Controller.

Time

The Data are processed for the time necessary to perform the service requested by the User, or required by the purposes described in this document, and the User can always ask for the interruption of treatment or deletion of data.

Purposes of the processing of collected data

The Data concerning the User is collected to allow the Owner to provide its services, as well as for the following purposes: Contacting the User, Advertising, Event Invitation, Payment Management, Searching and selecting personnel, Displaying content from external platforms, Statistics, Remarketing and behavioral targeting, Interaction with external social networks and platforms, Backup saving and management, SPAM protection, Heat mapping and session recording, Hosting and backend infrastructure and Registration and authentication.

Villa Pirreca by Angelo Reina, C.F. RNENGL81M01D423Y – as Data Controller (hereinafter the "Villa Pirreca" or "Controller") makes this information pursuant to Regulation (EU) 2016/679 - GDPR – to those who wish to register on the site VillaPirrecaFavignana.com (hereinafter the "Site").

Collection and purpose of the processing

Personal data are collected by the Data Controller through the Website, in particular by means of the specific form provided therein. The data collected will be processed by the Data Controller to manage your request for information or demo, or to subscribe to the newsletter and to inform you about news from Villa Pirreca, to send you information and promotional material through newsletters and other commercial communications, send any invitations to you regarding activities and promotions, as well as to fulfill the relevant legal obligations, and where necessary to exercise his rights in court.

Use of cookies

The "Web-site" (VillaPirrecaFavignana.com) uses cookies to make its services simple and efficient for users who view the page VillaPirrecaFavignana.com. Users that view the site, will have the

minimum amount of information inserted in the devices in use, either computers or mobile devices, in small text files called "cookies" saved in the directories used by the user's web browser. There are various types of cookies, some to make use of the Site more effective, others to enable certain features.

Analyzing them in detail, our cookies allow to:

- memorize the preferences entered;
- avoid re-entering the same information several times during the visit such as user name and password;
- analyze the use of the services and content provided by VillaPirrecaFavignana.com to optimize the browsing experience and the services offered.

Types of Cookies

Technical cookies

This type of cookies allows the proper functioning of certain sections of the Site. There are two categories of these cookies: persistent and session:

- persistent: once the browser is closed they are not destroyed but remain up to a preset expiration date
- session: they are destroyed every time the browser is closed.

These cookies, always sent from our domain, are necessary to view the site correctly and in relation to the technical services offered, will therefore always be used and sent, unless the user does not change the settings in the browser (thus disrupting the display of pages of the site).

Analytical cookies

Cookies in this category are used to collect information on the use of the site.

VillaPirrecaFavignana.com will use this information for anonymous statistical analysis in order to improve the use of the Site and to make the content more interesting and relevant to the wishes of users. This type of cookies collects anonymous data on the activity of users and on how they arrived to the Site. Analytical cookies are sent from the site itself or from third-party domains.

Analysis cookies for third-party services

These cookies are used in order to collect information on the use of the Site by users anonymously such as: pages visited, time spent, origins of the traffic of origin, geographic origin, age, gender and interests for the purpose of marketing campaigns. These cookies are sent from third-party domains external to the Site.

Cookies used to integrate products and functions of third-party software

This type of cookies integrates features developed by third parties within the pages of the site such as icons and preferences expressed in social networks in order to share site content or for the use of third-party software services (such as software used to generate maps and other software that offers additional services). These cookies are sent from third-party domains and from partner sites that offer their functionality on the pages of the Site.

Profiling cookies

These cookies are necessary to create user profiles in order to send advertising messages in line with the preferences expressed by the user within the pages of the Site.

VillaPirrecaFavignana.com, according to current legislation, is not required to seek consent for cookies and technical analytics, as necessary to provide the required services.

For all other types of cookies, consent may be expressed by the User with one or more of the following methods:

- By specific configurations of the browser used or the related computer programs used to navigate the pages that make up the Website.
- By changing settings in the use of third-party services

Both of these solutions may prevent the user from using or viewing parts of the Website.
